Introduction:-

1.0- As per government's earlier policy with the drinking water those proposals are receiving to the water resource department for giving the water reservation for all kinds of non-sprinkler purpose eg. Industry, atomic electric project, other non-sprinkler society etc. among them the water reservation are being less than 15 % of the available water stores of water irrigation departments reservoir, for this concerned Chief Engineer so also said proportion is having less than 15 % or up to 15% to 25%, for that sanction was according by the ministerial inter Divisional Secretary Level Committee. So also such proportion is having 25 % or more than 25% for that sanction was according by the sub-committee under cabinet ministry's Hon'ble Minister, Irrigation (by excluding Krushna Khore Portfolio) presidential Hon'ble Minister High Official Committee.

2.0 As per sub-section 16(c) of section 5 of the Maharashtra Water Resources Regulation Authority (Modification and Keeping Forward) Act 2011 the provision has been made that the Regional Distribution of water Resources will be done by Cabinet Ministry.

In this connection the Government has now taken the following decision -

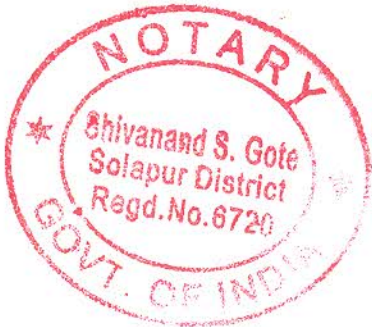

4.0. Consent is giving to the aforesaid mentioned proposals subject to the following conditions -

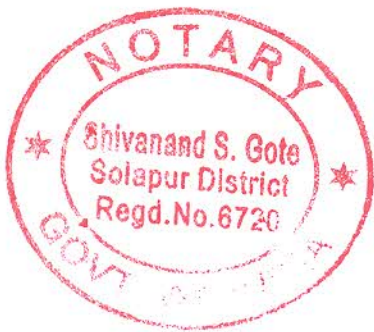
1. Society towards reduction of sprinkler, the reinstate cost of sprinkler Rs. 1 Lakh per hector or at the time of execution of agreement the prevalent rate of government in force among which those rate is higher has to be deposit with government. The reinstate cost before execution of agreement. Such sprinkler reinstate cost amount receiving due to water reservations sprinkler has to be utilized towards the scheme of

that sprinkler reinstatement project area. However, being the Grampanchayat are not financially competent, from them no cost of Sprinkler, reinstatement has to be recovered.

2. Considering the present industrial water bill without taking capital contribution from society water bill has to be recovered as per government's prevalent industrial rate.
3. For the domestic water use water bill has to be recovered as per government's prevalent rate.
4. Generally the planning of minor irrigation project will be for 8 months. So that in the summer the water of said project is dried up (water not at all). Hence, under exceptional circumstance water supply schemes other any water resources are not available to them sanction is being given. Such sanction giving water supply schemes there will be no guarantee to get water in summer. For that it is necessary to society to make the necessary stock.
5. If the societies demand is having for the construction of proposed urban colony then from the society till the actual formation of locality total water bill has to be recovered as per industrial rate and after completion of locality for domestic purpose at domestic rate and for industrial purpose at industrial rate water bill has to be recovered.
6. In the emergency circumstance society has to make its own alternative arrangement. At the origin place due to lack of water or in emergency situation for the fulfillment of water need the society has to construct by its own costs the water tank of the capacity of water to be used for 60 days. So also in this period if water will not be available there will not be any responsibility of irrigation department.
7. Probably industries take gestation period for their production. Generally in this period society is avoiding to execute agreement or even non-sprinkler agreement is execution with society, still no water will be receiving to government. However, being the water reservation is made by the society from them no water is being used, it will not be possible to give it to other applicants. So the government has to lose huge revenue, by considering this

aspects 5 % of annual water reservation assessments has to be recovered from society for every year as commitment charges. So also as the industrial project is completed, accordingly as per water use further water bill be assessed.

8. Society has to install purification process machinery on drain water. So also regarding this the information of detailed proposal is required to give to water resource/environment department in prescribed time means at the time of execution of agreement. Otherwise water reservation will be cancelled.
9. To the society first the letter of intent be given for the permission of water use and time of three months be given for execution of agreement. After execution of agreement it will be presumed that the actual permission is given. If the society is not executed such agreement in prescribed period (within 3 months) societies water reservation will automatically be cancelled.

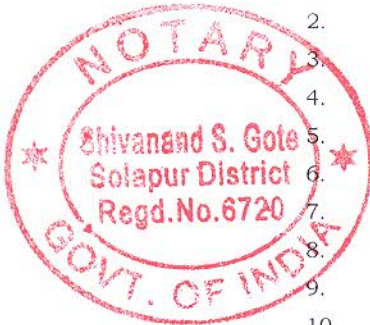
